Finding a Job

Federal Government Employment



Federal government jobs are available across the country. Schedule A hiring allows people with a Targeted Disability or Serious Health Condition preference in hiring for jobs with the federal government or hiring on a non-competitive basis. A partial or complete paralysis of any cause, including a spinal cord injury, is considered a Targeted Disability under the Schedule A hiring authority.

You must provide a special letter, often called "a Schedule A Letter" to prove you qualify for Schedule A hiring. You can find sample letters in the resources on the next page. You can give the sample letter to your doctor or other licensed medical and rehabilitation professions to put on their letterheads and sign for you.

You can also set up a profile, and search for jobs online at https://www.usajobs.gov/. You will want to prepare a searchable resume, meaning a word document and not a pdf. You can include your searchable resume in your profile. You can put in your resume that you want to be considered for a schedule A position, so federal agencies looking to hire people with disabilities can find you through your profile.
